3.4 ADJUSTING

- B. Adjust transaction drawers to provide a tight fit at contact points for smooth operation and [weathertight and] secure enclosure.
- C. Remove and replace defective work [, including security windows that are warped, bowed, or otherwise unacceptable].

3.5 CLEANING AND PROTECTION

- A. Section 01 70 00 - Execution and Closeout Requirements {01700 - Execution Requirements}: Requirements for cleaning.
- B. Remove protective material from factory finished surfaces.
- C. [Wash surfaces by method recommended and acceptable to sealant and window manufacturer; rinse and wipe surfaces clean.]
- D. Clean metal and glass surfaces to polished condition.
 - 1. Lubricate transaction drawer hardware.
- E. Provide temporary protection to ensure that equipment is without damage at time of Substantial Completion.

3.6 DEMONSTRATION

- A. Engage a factory-authorized service representative to train Owner's maintenance personnel to adjust, operate, and maintain transaction drawers.
